TERMS AND CONDITIONS:

(Deposits, additional and final payments) **\$500 deposit (\$300 refundable up to 12/24/19)** is required to secure a reservation. SON-Partners in Prayer shall be responsible only for funds confirmed paid to and received by SON-Partners in Prayer. Upon receipt of deposit, passenger will receive a statement showing all charges, payments and discounts if applicable. Total payment due by November 22, 2019. Payment may be given or mailed direct to SON-Partners in Prayer: PO Box 4338, Albuquerque, NM 87196. Each passenger must complete a **Registration/Payment/Medical Form** when reserving the trip. Additional payments may be made at any time, with payment in full due by November 22, 2019. Items of a personal nature such as laundry, lunch, and dinner beverage, transportation from your hometown to the airport of departure and vice versa, tips for personal favors, insurance, gratuities, and costs resulting from absence or deviation from the itinerary and any items not shown herein as being included are the responsibility of the passenger. Local transportation by air-conditioned motor coach or local conveyance as indicated, and the service of an English speaking guide and the entrance fees to places visited on sightseeing and optional tours described in the itinerary, are all included in the tour prices. DEVIATIONS:

Any deviation request for this tour, will incur a charge of \$100, plus any charges of suppliers, airlines, steamship lines involved in accommodating the deviation. Trips outside the USA require a valid passport or other acceptable forms of citizenship (proof). You are responsible for, and release Operator from, passport, visa, vaccination requirements (if applicable), and safety conditions in travel destinations. Your passport must be valid up to September 8, 2020.

CANCELLATION INFORMATION:

All cancellations must be in writing to SON-Partners in Prayer and must be signed by the person who made the original reservation. Cancellations are only effective from the day they are actually received by SON-Partners in Prayer. No refunds are issued for cancellations received after the departure date of the tour. Penalties will apply if you cancel your tour. Cancellation fees and penalties will be deducted from your refund. Cancellation fees apply to each person. Cancellation policy is as follows: Up to \$300 refunded on deposit until December 24, 2019. Full deposit of \$500 is non-refundable 90 days prior to departure (on or after December 24, 2019). Full tour payment is non-refundable 60 days prior to departure.
